

PDI EVS Week Lunch Sweepstakes OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED. PDI EVS Week Lunch Sweepstakes ("Sweepstakes") begins at 8:00:00 AM Eastern Time ("ET") on July 20, 2024 and ends at 11:59:59 PM ET on September 14, 2024 ("Sweepstakes Period"). The computer clock of Administrator is the official time-keeping device in the Sweepstakes.

- 1. ELIGIBILITY:** The Sweepstakes is open only to legal residents of the fifty (50) United States and the District of Columbia (the "Territory"), who are (i) at least eighteen (18) (except Alabama and Nebraska – 19, and Mississippi – 21) years of age at the time of Sweepstakes registration, and (ii) environmental services employees of a hospital in the Territory ("Associated Hospital"). All e-mail entries must be received by September 9, 2024 at 11:59:59 PM ET.
- 3. PRIZES/PRIZE RESTRICTIONS:** One (1) winner from each of the five (5) Regions (as defined below) will be selected by random drawing at a rate of one (1) winner per day beginning on September 16, 2024 and ending on September 20, 2024. Five (5) grand prizes of locally-catered lunch (each with an approximate value of up to \$500) to be provided at each winner's Associated Hospital will be awarded. Each entry drawn from each Region will be declared a potential winner. Entrants are not required to be present to win. - e. Region E: Alaska, Arizona, California, Hawaii, Idaho, Montana, Nevada, Oregon, Utah, Washington.

this Sweepstakes is terminated before the designated end date, Sponsor will (if possible) select the potential winner(s) in a random drawing from all eligible, non-suspect entries received as of the date of the event giving rise to the termination. Inclusion in such drawing shall be each entrant's sole and exclusive remedy under such circumstances.
