



PDI IIPW Gift Card Sweepstakes OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED. PDI IIPW Gift Card Sweepstakes (“Sweepstakes”) begins at 8:00:00 AM Eastern Time (“ET”) on October 14, 2024 and ends at 11:59:59 PM ET on October 18, 2024 (“Sweepstakes Period”). The computer clock of Administrator is the official time-keeping device in the Sweepstakes.

- 1. ELIGIBILITY:** The Sweepstakes is open only to legal residents of the fifty (50) United States and the District of Columbia (the “**Territory**”), who are (i) at least eighteen (18) (except Alabama and Nebraska – 19, and Mississippi – 21) years of age at the time of Sweepstakes registration, and (ii) environmental services employees of a hospital in the Territory (“**Associated Hospital**”). Employees of Professional Disposables International, Inc. All e-mail entries must be received by October 18, 2024 at 11:59:59 PM ET.
- 3. PRIZES/PRIZE RESTRICTIONS:** Five (5) winners will be selected by random drawing at a rate of one (1) winner per day beginning on October 14, 2024 and ending on October 18, 2024. There will be a total of five (5) grand prizes awarded, each grand prize consisting of a gift card (each with an approximate value of \$50) to be provided to each winner. Entrants are not required to be present to win. Odds of winning depend on the total number of valid and qualifying entries received. **AN ENTRANT IS NOT AN OFFICIAL WINNER UNLESS AND UNTIL ENTRANT’S ELIGIBILITY HAS BEEN VERIFIED AND ENTRANT HAS BEEN ADVISED BY SPONSOR THAT VERIFICATION IS COMPLETED.** One prize per winner only. By entering, you agree that all issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, participants' rights and obligations, or the rights and obligations of the Sponsor in connection with the Sweepstakes, shall be governed by, and construed in accordance with, the laws of the State of New York, without giving effect to any choice of law or conflict of law rules, and you consent to the jurisdiction and venue of the federal, state and local courts located in New York. - 5. NOTIFICATION/PRIZE ACCEPTANCE:** Sponsor will notify the potential winner(s) within five days after each respective random drawing is held. The potential winner(s) will be notified via the email provided in their submissions. The potential winner(s) must respond to Sponsor's email message within five business days of Sponsor's first notification attempt – failure to do so will result in forfeiture of the prize. If the potential winner entered via the AMOE, such potential winner will be notified via the e-mail address contained in such entry, and such potential winner must respond via email to Sponsor within five business days of Sponsor's first notification attempt – failure to do so will result in the forfeiture of the prize. Upon verification by Sponsor of the potential winner's eligibility under these Official Rules, the potential winner(s) must accept the prize by returning to Sponsor a completed and personally signed Affidavit of Eligibility and Liability/Publicity Release, except where prohibited by law, and an IRS tax form W-9 within ten business days of Sponsor's first notification attempt – failure to do so will result in forfeiture of the prize. Any action seeking legal or equitable relief arising out of or relating to the Sweepstakes or these Official Rules shall be brought only in the courts of the State of New York. You hereby irrevocably consent to the personal jurisdiction of said courts and waive any claim of forum non-convenience or lack of personal jurisdiction they may have.
8. **DISQUALIFICATION/FORCE MAJEURE:** Sponsor reserves the right to modify, extend or terminate this Sweepstakes if it determines, in its sole discretion, that this Sweepstakes is technically impaired or corrupted or that fraud or technical problems, failures or malfunctions or other causes beyond Sponsor's control have destroyed or severely undermined or to any degree impaired the integrity, administration, security, proper play and/or feasibility of this Sweepstakes as contemplated herein. If an insufficient number of eligible entries are received and/or Sponsor is prevented from awarding the prize or continuing with this Sweepstakes as contemplated herein by any event beyond its control, including but not limited to fire, flood, natural or man-made epidemic or pandemic of health or other means, earthquake, explosion, labor dispute or strike, act of God or public enemy, satellite or equipment failure, riot or civil disturbance, terrorist threat or activity, war (declared or undeclared) or any federal, state or local government law, order, or regulation, public health crisis (e.g. Coronavirus COVID-19), order of any court or jurisdiction, or other cause not reasonably within Sponsor's control (each a "Force Majeure" event or occurrence), Sponsor shall have the right to modify, extend or terminate this Sweepstakes. If this Sweepstakes is terminated before the designated end date, Sponsor will (if possible) select the potential winner(s) in a random drawing from all eligible, non-suspect entries received as of the date of the event giving rise to the termination. Inclusion in such drawing shall be each entrant's sole and exclusive remedy under such circumstances.
