OFFICIAL RULES**

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED. PDI IIPW Gift Card Sweepstakes (“Sweepstakes”) begins at 8:00:00 AM Eastern Time (“ET”) on October 15, 2025 and ends at 11:59:59 PM ET on October 24, 2025 (“Sweepstakes Period”). The computer clock of Administrator is the official time-keeping device in the Sweepstakes.

- 1. ELIGIBILITY:** The Sweepstakes is open only to legal residents of the fifty (50) United States and the District of Columbia (the “**Territory**”), who are (i) at least eighteen (18) (except Alabama and Nebraska – 19, and Mississippi – 21) years of age at the time of Sweepstakes registration, and (ii) environmental services employees of a hospital in the Territory (“**Associated Hospital**”). Employees of Professional Disposables International, Inc. - 3. PRIZES/PRIZE RESTRICTIONS:** Three (3) winners will be selected by random drawing on October 27, 2025. There will be a total of three (3) grand prizes awarded, each grand prize consisting of a gift card (each with an approximate value of \$25) and a badge reel (each with an approximate value of \$10) to be provided to each winner. Entrants are not required to be present to win. The potential winner(s) must respond to Sponsor's email message within five business days of Sponsor's first notification attempt – failure to do so will result in forfeiture of the prize. If the potential winner entered via the AMOE, such potential winner will be notified via the e-mail address contained in such entry, and such potential winner must respond via email to Sponsor within five business days of Sponsor's first notification attempt – failure to do so will result in the forfeiture of the prize. If this Sweepstakes is terminated before the designated end date, Sponsor will (if possible) select the potential winner(s) in a random drawing from all eligible, non-suspect entries received as of the date of the event giving rise to the termination. Inclusion in such drawing shall be each entrant's sole and exclusive remedy under such circumstances.
